R. Richter presented both Item A and Item B together. He stated there were currently three existing self-storage buildings on the parcel, along with a building that was being used as a hair salon. He continued to state they were proposing to add onto the three existing self-storage buildings currently on site, demolish the hair salon structure, and add another self-storage building west of the three existing storage buildings. He stated there would be a security/privacy fence around the North and East boundaries. There would also be fencing around the Southern and Western boundaries of the property. S. Rempert asked what the remaining issues were, as far as being compliant with the ordinance. R. Richter stated they need to include evergreen trees as required for buffering, remove one of the existing monument signs and construct a pole sign for the self-storage facility. L. Ternet stated the Town was going to start requiring a lock box for all commercial projects so the fire department can gain access to buildings with minimal damage for entrance. She continued to state the petitioner would need to come back before the Board of Zoning Appeals to obtain a variance of the fence height from 4ft to 6ft. The meeting was opened to the public. No public comment. D. Potter made a motion to approve. M. Chatham seconded the motion. Motion carried 7-0.
